Health and Relationships Campus Survey: Stalking and Cyberstalking among College Students

Data Summary

Between April 7, 2021, and April 30, 2021, emails were sent to 5,000 students through Webtools.

Eligibility: in their freshman or sophomore year at UIUC (2,500 in freshmen year; 2,500 in sophomore year). Within each class year, sample will be divided by gender/sex. Sample is generated by DMI.

- April 7: Initial Email
 - o 2,521 unique full opens (50.41%) and 313 people clicked the link (9.36%)
- April 14: Reminder #1
 - o 2,723 unique full opens (54.45%) and 165 people clicked the link (6.06%)
- April 21: Reminder #2
 - o 2,752 unique full opens (55.02%) and 173 people clicked the link (3.46%)
- April 28: Final 24 hours
 - o 2,520 unique full opens (50.40%) and 144 people clicked the link (5.71%)

720 surveys were completed via REDCap (556 Amazon e-codes were sent to provided email addresses) – duplicates were not sent gift-cards and their second surveys were removed. There were three quality check questions. If respondents completed 0 or only 1 quality check question correctly, they were removed from the sample. Five students completed the survey but did not provide an email address for the Amazon e-code. A total of 561 students were included in the final sample for data analyses.

Respondents ranged in age from 18 to 24 (M = 19.02, SD = 0.956).

I. Stalking & Cyberstalking

Stalking Victimization

There were 11 items to assess stalking victimization.

55.1% (n = 308) endorsed experiencing at least one act of stalking in their lifetime.

Among those who experienced at least one act of stalking:

- 49.4% felt a degree of "being afraid."
 - o 17% of individuals felt "very afraid" or "terrified."
- About 37.9% (or about 1 in 3 individuals) felt "only concerned."
- Only 12.7% were "not afraid at all"

Participants were asked to reflect on the extent to which these experiences amounted to "stalking." About 31% felt that the experiences were "definitely not stalking." Approximately 18.6% were unsure.

Cyberstalking Victimization

There were 12 items to assess cyberstalking victimization.

48.9% (n = 273) endorsed experiencing at least one act of cyberstalking victimization in their lifetime.

Among those who experienced at least one act of cyberstalking:

- 42.5% felt a degree of "being afraid."
 - o 11.1% of individuals felt "very afraid" or "terrified."
- About 29.2% (or about 1 in 3 individuals) felt "only concerned."
- Only 28.4% were "not afraid at all"

Participants were asked to reflect on the extent to which these experiences amounted to "cyberstalking." About 28.4% felt that the experiences were "definitely not cyberstalking." Approximately 19.9% were unsure.

Stalking & Cyberstalking Victimization: Perpetrator

Participants were asked who they experienced stalking or cyberstalking experiences from. The two top perpetrators of stalking or cyberstalking are from an ex-partner (23.4%) or a romantic or dating partner (21%).

Obsessive Relational Intrusion (ORI)

Participants were asked if they had ever been "persistently followed and/or harassed in a manner in which they clearly made it known that such attention or intrusions were unwanted."

Approximately 15.2% (n = 85) of participants had experienced ORI. Of these participants, 49.5% felt fearful for their safety, or the safety of their family, friends, pets, or property.

Stalking and Cyberstalking Perpetration

There were 11 items to assess stalking perpetration and 12 items to assess cyberstalking perpetration.

21.5% (n = 120) endorsed perpetrating at least one act of stalking; 45.2% (n = 252) endorsed perpetrating at least one act of cyberstalking.

II. <u>Intimate Partner Violence</u>

There were 10 items to assess for intimate partner violence victimization and 10 items to assess for perpetration.

48.1% (n = 187) experienced at least one act of IPV victimization; 26.5% (n = 102) endorsed perpetrating at least one act of IPV.

III. Sexual Violence

Across items, participants were asked if the following happened to them by (a) Telling lies, threatening to end the relationship, threatening to spread rumors about me, making promises I knew were untrue; (b) Showing displeasure, criticizing my sexuality or attractiveness, getting angry but not using physical force, after I said I didn't want to; (c) Taking advantage of me when I was too drunk or out of it to stop what was happening; (d) Threatening to physically harm me or someone close to me; (e) Using force, for example holding me down with their body weight, pinning my arms, or having a weapon.

Across experiences, 28.2% of respondents experienced at least one act of sexual violence (n = 154). Most individuals experienced violence from a cisgender male (85.5%).

IV. Adverse Childhood Experiences (ACEs)

Ten ACEs were asked that include experiences with childhood abuse and neglect, as well as exposure to household adversities. Across the original ten ACEs, 60.8% of participants experienced at least one form of adversity. The most common form of adversity experienced was emotional abuse (34.9%). Approximately 17% of participants endorsed four or more of the original ACEs.

Across the expanded ACE questions, about a fourth of participants were exposed to community violence (24.9%).
